## INVITATION TO BID Exterior Repainting of PNOC Bldg.6

- The Philippine National Oil Company (PNOC), through the 2021 Approved Corporate Operating Budget intends to apply the sum of Four Million Eight Hundred Fifty Thousand Pesos (PhP4,850,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Exterior Repainting of PNOC Building 6 with identification number 2021-10-230. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PNOC now invites bids for the above Procurement Project. Delivery of Goods and Services is required within One Hundred (100) calendar days upon receipt of Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA.5183.
- 4. Interested bidders may obtain further information from the PNOC-Procurement Management Division and inspect the Bidding Documents at the address given below during working hours from 8:00 AM to 5:00 PM.
- A complete set of Bidding Documents may be acquired by interested Bidders on 28 October 2021 from the given address below and upon payment of a non-refundable fee amounting to Five Thousand Pesos (PhP5,000.00). The procuring entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

- 6. The PNOC will hold a Pre-Bid Conference on *04 November 2021, 10:30A.M.* at 4/F Meeting Room, PNOC Bldg. 6, Energy Center, Rizal Drive, BGC, Taguig City and/or through video conferencing via *Zoom*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address indicated below on or before 16 November 2021, 10:00A.M. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on **16 November 2021, 11:00A.M.** at given address below and/or via **Zoom**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The PNOC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
