KNOW ALL MEN BY THESE PRESENTS:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, OLIVER B. BUTALID, and hereinafter referred to as the "ENTITY";

SMARTGEO SURVEYING AND GEOMATICS, a general professional partnership duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 21 Consul St., Brgy.
